ONTARIO BUILDING CODE UPDATE:

There was an OBC Part 3 TAC meeting on Friday, April 30th. This meeting was called to review public comments, letters, etc. and make recommendations to the MMAH about mid-rise combustible construction. Apparently the meeting started off with the review but then quickly escalated to a roundtable discussion about what every-one thought about the proposed changes....the first 6-7 people, including some fire association members, had a real issue with the lack of research and supporting information that would justify the changes.

The TAC rejected the code changes mainly due to the lack of substantiation to simply prescribe six storey wood frame design and construction. It was also acknowledged that the national code process will be engaged in looking at this issue in the NBCC 2015 code cycle.



CCMPA will continue to monitor these developments.

In the interim, there was a massive fire in Richmond, BC involving the first six storey wood frame structure being built under the new mid-rise requirements in the B.C. Building Code. As expected the building burned to the ground.

The National Energy Code for **Buildings has Heated Up**

The Public Review period is completed, negative comments have been resolved by the Standing Committee on Energy

Efficiency in Buildings (SCEEB), and the Canadian Commission on Building and Fire Codes (CCBFC) is satisfied that due -processes have been followed. The National Energy Code for Buildings (NECB 2011) is now scheduled for publication in the fall of this year, in readiness to serve as a model energy code for adoption and legislation by the provinces and territories, likely in 2012.

The NECB 2011 is intended to apply to other than Part 9 buildings, that is, to buildings that are constructed in accordance with Part 3, 4, 5, and 6 of the National Building Code of Canada. [An energy code intended to apply to Part 9 structures, Housing and Small Buildings, is currently under development by a Joint Task Group consisting of representatives from the SCEEB and the Part 9 Standing Committees. It is nearing development, continues to be monitored by CCMPA, and will undergo Public Review in the fall of this year.]

The NECB 2011 replaces the Model National Energy Code for Buildings, published in 1997; a model energy code which, for a number of reasons was not adopted by most provinces and territories. Assuredly, the outcomes for this NECB will be different. The provinces and territories were major-drivers of the NECB 2011 and have committed to adopting and legislating this Code either as-is, or with some change to satisfy regional sensitivities. To assist these key partners in facilitating the implementation of their policy goals and to improve the likelihood of broad provincial/territorial adoption the NECB

2011, shortly, a guideline document will be produced by SCEEB and the Canadian Codes Centre that will provide specific details on how the requirements of the NECB 2011 can be modified to achieve the specific policy needs of each of the provinces and territories.

Using the 1997 MNECB as a baseline performance level, the working target for the changes and requirements in the NECB 2011 was an energy performance target of 25% better than the 1997 MNECB. This was assessed by comparing the energy usage of buildings when designed to the MNECB 1997 against their energy usage when designed to the NECB 2011. SCEEB and the CCBFC are satisfied that this energy performance level has been reached.

The Province of Ontario is the first to begin the adoption process. In its new proposed energy requirements intended for the next edition of the Ontario Building Code, and introduced during the Public Review period that ended in the spring of this year, the NECB was named as one of three options for code compliance.
